Bidders are advised to go through the LTE document carefully and understand various provisions contained therein along with their implications. Proposal/Bid documents must be arranged in a following manner i.e. 1) EMD, 2) Annexure-A (Bidders Details) with all supporting documents, Copy of LTE duly signed by the bidder, 4) Annexure-B (Schedule of Rate) etc.

New Delhi-110002 in the presence of the tenderers or their representatives, who wish to be present. Due to COVID-19, opening of LTE through video conferencing shall also be considered. If the LTE opening date is declared a holiday by Govt of India then the LTE shall be opened on next working day at 04:00 PM at same place and venue. It is made clear that if the services rendered by the firm are not found satisfactory during the period of contract, the contract is liable to be cancelled without any notice. The empanelment of entity is further subject to the following terms and conditions:-

Terms and Conditions

- 1. LTE/Quotation received after due date and time, those received without sealed cover, Annexure-A (Bidders Details) with all supporting/necessary documents and rates not quoted in the proforma given in Annexure-B (Schedule of Rate), will not be accepted/considered for evaluation.
- 2. The firm should have their contact office in Delhi/NCR.
- 3. The Firm should have at least 5 years' experience of providing newspaper/magazine clipping in PSU's/Ministries/ Corporate houses on a daily basis. Necessary supporting document must be attached with LTE/Quotation, failure which proposal shall not be considered.
- 4. Copy of PAN Card/GST Number must be attached with LTE/Quotation, failure which proposal shall not be considered.
- 5. <u>EMD -</u> The tenderer will be required to deposit a sum of Rs.5,000/- (Rupees Five Thousand only) as earnest money by way of Pay Order or Demand Draft made in favour of TRAI and payable at New Delhi.
- 6. Exemptions from EMD in case of MSMED Act 2006 will be available to registered entities under the MSMED Act 2006. Bidder must enclose MSME Certificate with LTE/Quotation, failure which proposal shall not be considered.
- 7. A self-certificate to the effect that the tenderer has not been blacklisted by Central/State Govt./Public Sector Units or its contracts have not been terminated on account of poor performance, be attached with LTE/Quotation, failure which proposal shall not be considered.
- 8. A complete Copy of LTE duly signed by bidder and affixing seal must be attached with proposal.
- 9. At the initial stage, the contract shall be awarded for a period for one year from the date of commencement of the Agreement.
