Limited Tender Enquiry (LTE)

SUBJECT: LIMITED TENDER ENQUIRY FOR "TRANSCRIPTION OF AUDIO RECORDINGS OF PROCEEDINGS OF CONFERENCE/SEMINARS FROM DELHI BASED TRANSCRIPTION AGENCIES/FIRMS".

The undersigned on behalf of the Telecom Regulatory Authority of India (TRAI) is directed to invite sealed Limited Tender Enquiry (LTE) for "Transcription of Audio Recordings of Proceedings of Conference/Seminars from Delhi Based Transcription Agencies/Firms as per the Bid Proforma given in Annexure-I on the terms & condition given below: -

TERMS AND CONDITIONS OF LTE

- 1. Participation in this tender is by invitation only and is limited to the selected firms. Unsolicited offers are liable to be ignored. However, firms who desire to participate in such tenders in future may bring it to the notice to the Undersigned/TRAI for registration.
- 2. LTE must be in the form furnished by TRAI and should be free from corrections/erasures. In case there is any unavoidable correction it should be properly attested. If not, the Tender will not be considered. Tender written in pencil will not be considered.
- 3. The firm must have an average annual turnover of Rs. 1,50,000/- (Rupees One Lakh fifty thousand only) or more for the last three (3) financial years. Copies of the proof in this regard should be enclosed in the form of certificate from Chartered Accountant.
- 4. Estimated cost of the work is approximately Rs. 3,00,000/- (Rupees Three Lakhs only) for
- 5. Bidder is required to quote their rates as per the Bid Proforma given in Annexure-I.
- 6. TRAI reserves the right to accept the offer and reject any or all tenders without assigning any reason there of and does not bind itself to accept lowest quotations.
- 7. TRAI also reserves right to relax or modify any tender conditions at any stage, if considered necessary for the purpose of finalizing the contract in the interest of TRAI.
- 8. A complete set of Tender Documents may be downloaded from TRAI website i.e. http://www.trai.gov.in/content/Tender.aspx and also from CPP Portal. In case the bidders need any clarification regarding any terms and conditions of the bid document, the bidder may seek clarification from the undersigned in person or telephonically before the last date of submission of tender.
- 9. At the initial stage, the contract shall be awarded for a period of two years from date of submission of Security Deposit/Performance Bank Guarantee amount. TRAI will have the discretion for extending it for a further term of one or more year on mutually acceptable terms and conditions. However, a formal agreement between TRAI and successful bidder is to be signed separately.
- 10. However, it will be obligatory on the part of the firm to continue to work at the rates prevailing on the last date of the Agreement even beyond contract period for at least 6 (six) months or till the new contract is finalized, whichever is earlier.
- 11. Proof of registration for GST registration number shall be attached. A self-certificate shall be given in case the tenderer is not covered under GST.
- 12. The prices quoted should be firm till the completion of contract period. Please quote the rates in words and figures. Rates quoted should be free delivery at destination including all charges otherwise the LTE is likely to be rejected. If there is no indication regarding the FOR, in the quotation, then it will be considered as FOR destinations.
- 13. In case TRAI office will shift from present location to another location, within NCR services will be made available by vendor at new location at the same rate, terms and conditions.
- 14. The successful Tenderer whose rates are finally accepted must deposit an amount of 03% of the contract value of 24 months as Security Deposit/Performance Bank Guarantee within 15 days from the of issue of work order. PBG should remain valid for period of 26 months.

- 15. Formal Agreement with the successful bidder will be signed after deposit of Security Deposit/Performance Bank Guarantee.
- 16. No interest will be payable on the Security Deposit/Performance Bank Guarantee and the Security Deposit/Performance Bank Guarantee will be returned/released only after successful completion of the contract period.
- 17. The firm shall take prompt corrective action in response to the complaints received by it through it's visiting representatives on same day provided, however, in case the complaints are received in the evening the same will be attended on next day before lunch. Rs. 200/- (Rupees Two hundred only) per day, per work will be levied as fine and same will be deducted from monthly bill for non-attending the complaint/rectification in work within given time schedule.
- 18. No request for revision of rates shall be entertained during the currency of the contract.
- 19. The firm shall provide functional mobile phones/Landline Telephone Numbers of Company for urgent communications.
- 20. The company will provide services to TRAI as Monday to Friday 9:30 AM to 6:00 PM on all working days. If requires, the Company will provide service on holidays too.
- 21. If during the contract period, the services are not provided satisfactorily, TRAI reserves the right to terminate the contract by giving one month notice and PBG shall be forfeited.
- 22. If the work is not done satisfactorily by firm and due to that account TRAI is forced to get the work done at risk and cost from elsewhere, that cost will be recovered Security Deposit/Performance Bank Guarantee of the defaulting bidder.
- 23. The firm blacklisted at any point of time by any Ministry/Department need not apply. In case the fact is concealed, and it will come to the notice of the TRAI, during the period of contract, the contract shall be terminated straightway, and the Security Deposit/Performance Bank Guarantee will be forfeited. If the fact comes to notice before award of contract, his bid shall be rejected outright & tender may be awarded to L2 bidder. A declaration to the effect that the tenderer has not been blacklisted by Central/State Government Public Sector Units or its contracts have not been terminated on account of poor performance during last 3 years as per Annexure-II shall also be submitted.
- 24. The bidder will be required to keep the offer open for a period of 90 (Ninety) days from the date of opening of the LTE.
- 25. Bidder is also required to attach duly signed copy of this LTE along with its bid.
- 26. In the event to any dispute arising between TRAI and the firm in any matter or arising directly or indirectly, the matter shall be referred to the Advisor (A), TRAI who may himself act as sole arbitrator or may nominate an officer of TRAI as sole arbitrator, notwithstanding the fact that such officer has been directly or indirectly associated with the contract. The firm will not be entitled to raise any objection for the appointment of such officer of TRAI as the sole arbitrator. The award of the arbitrator shall be final and binding on both the parties to the agreement subject to provisions of Arbitration and Conciliation Act, 1996 and rules made there under. The parties expressly agree that the arbitration proceedings shall be held at New Delhi. The language of arbitration shall be in English/Hindi only.
