Sir,

The Telecom Regulatory Authority of India (TRAI), New Delhi, is a statutory body set up under an Act of Parliament viz. the TRAI Act, 1997. The organization proposes to prepare a panel of officers having the required experience for appointment as Advisor in Economic Regulation Division on deputation basis initially for a period of two years. The details of qualifications and experience, etc., are as under:-

Rules.	<p>Officers of the Central Government, Public Sector Undertakings and Statutory and Autonomous Bodies (i) holding equivalent post or (ii) officers in Selection Grade with six years of regular service in that grade or (iii) Group A officers having twenty years of regular service in Group A of which at least six years of continuous service shall be in the Selection Grade.</p> <p>Essential: A Master /Bachelor's Degree in Business Administration/Economics/Commerce/Engineering/Law/Science/Humanities from a recognized University/institution or, Membership of the Institute of Chartered Accounts of India/Institute of Cost and Works Accounts of India, and possessing requisite experience in the economic field.</p> <p>Age: Not exceeding 56 years on the date of closing of applications.</p>

2. The appointing authority may, from time to time, by appropriate order, appoint on permanent absorption basis any person already appointed on deputation in the Authority in accordance with the provisions contained in TRAI appointment regulations.

3. TRAI has been exempted from the rule of immediate absorption upto 23.01.2011 by Department of Pension & Pensioner's Welfare for appointment on deputation. However, TRAI has taken up the matter with the Govt. for exemption from the applicability of the rule of immediate absorption for all posts in TRAI.

4. All the Ministries/Departments/Public Sector Undertakings/Statutory and Autonomous bodies are requested to forward applications in the enclosed proforma (can also be down loaded form TRAI website: www.trai.gov.in) alongwith attested copies of ACRs for the last five years and vigilance clearance of eligible candidates whose services could be placed at the disposal of the Authority immediately in an envelope superscribing the post applied for so as to reach the Senior Research Officer (A&P), Telecom Regulatory Authority of India, Mahanagar Door Sanchar Bhawan, J.L. Nehru Marg, (Old Minto Road), Next to Zakir Husain College, New Delhi - 110002 on or before **20th July 2009**.
