3. The posts of Deputy Advisor/Joint Advisor and Senior Research Officer have been exempted upto 23.1.2016 and 23.05.2016 respectively from the rule of immediate absorption by Department of Pension & Pensioners Welfare for appointment of Central Government servants on deputation.
