

- ❖ Mobile Number Portability requests increased from 37.11 million subscribers at the end of February 2012 to 41.88[^] million at the end of March 2012. In the month of March 2012 alone, 4.76 million requests have been made for MNP.
- ❖ Active wireless subscribers on the date of Peak VLR in March 2012 are 683.02 Million, 74.31% of the total subscribers.
- ❖ Broadband subscription reached 13.79 Million in March 2012 from 13.54 Million in February 2012.


I. Total Telephone Subscribers

- The number of telephone subscribers in India increased to 951.34 Million at the end of March, 2012 from 943.49 Million at the end of February 2012, thereby registering a growth rate of 0.83%. The share of Urban subscribers has declined to 65.23% from 65.59% whereas share of Rural Subscribers has increased to 34.77% in the month of March 2012. With this, the overall Tele-density in India reaches to 78.66 at the end of March, 2012 from 78.10 of the previous month.



- Subscription in Urban Areas grew from 618.82 million in February, 2012 to 620.53 million at the end of March, 2012. Subscription in Rural Areas increased from 324.68 million to 330.82 million during the same period. The growth of Urban and Rural Subscription is 0.28% and 1.89% respectively. The overall Urban teledensity has increased from 169.37 to 169.55 and Rural teledensity increased from 38.53 to 39.22.

Overall Teledensity (Circle Wise)






II. Wireless Segment (GSM, CDMA & FWP)


- Total Wireless subscriber base increased from 911.17 Million in February 2012 to 919.17 Million at the end of March 2012, registering a growth of 0.88%. The share of Urban Subscriber has decreased from 65.20 % to 64.83% where as share of Rural Subscribers has increased from 34.80% to 35.17%. The overall wireless Tele density in India reaches 76.00.




- Wireless subscription in Urban Areas increased from 594.11 million in February 2012 to 595.90 million at the end of March 2012. The subscription in Rural Areas increased from 317.06 million to 323.27 million during the same period. This shows higher growth in Rural Subscription (1.96%) than Urban Subscription (0.30%). The Urban wireless teledensity has increased from 162.61 to 162.82 and Rural teledensity has increased from 37.62 to 38.33. Detailed statistics is at Annexure I.

- Private operators hold 88.65% of the wireless market share whereas BSNL and MTNL, two PSU operators hold only 11.35% market share. The graphical presentations of market shares and shares in net additions of all the service providers during the month of March, 2012 are given below:



III. VLR Data

Out of the total 919.17 Million wireless subscribers, 683.02 Million were active on the date of Peak VLR for the month of March 2012*. The proportion of VLR subscribers is approximately 74.31% of the total wireless subscriber base reported by the service providers.


Circle-wise, J&K has the highest proportion of VLR subscribers with 84.46% followed by Assam (82.40%) and MP (81.48 %); Mumbai has the lowest proportion with 64.11%. Service Provider wise, Idea leads the tally with 93.45% followed by Bharti (91.73%); STel is at the bottom with 28.53%. The detailed statistics of proportionate VLR is at Annexure II & methodology used for reporting subscriber base/active subscribers is at Annexure IV.

IV. Mobile Number Portability


As per the data reported by the service providers, by the end of March 2012 about 41.88 million subscribers have submitted their requests to different service providers for porting their mobile number. In MNP Zone-I (Northern & Western India) maximum number of requests have been received in Gujarat (3.88 million) followed by Rajasthan (3.71 million) whereas in MNP Zone-II (Southern & Eastern) maximum number of requests have been received in Karnataka (4.53 million) followed by Andhra Pradesh Service area (3.99 million). In the month of March 2012, total number of subscribers who have submitted their request for MNP is 4.76 million. The status of MNP requests in various service areas is given below:

V. Wireline Segment


Wireline subscriber base declined from 32.33 Million at the end of February 2012 to 32.17 Million at the end of March 2012. The share of Urban Subscribers has increased from 76.43% to 76.54% where as share of Rural Subscribers has declined from 23.57% to 23.46%. The overall wireline teledensity has marginally decreased from 2.68 in February 2012 to 2.66 in March 2012, with urban and rural teledensity being 6.73 and 0.89 respectively. BSNL and MTNL, two PSU operators hold 80.59% of the Wireline market share. Detailed statistics is at Annexure-III. 

VII. Broadband (\geq 256 Kbps download)

Total Broadband subscriber base has increased from 13.54 million at the end of February 2012 to 13.79 million at the end of March 2012, thereby showing a monthly growth of 1.86%. Yearly growth in broadband subscribers is 14.80% during the last one year (March 2011 to March 2012).

As on 31st March 2012, there are 155 Internet Service Providers (ISPs) which are providing broadband services in the country. Top three ISPs in terms of market share are: BSNL, Bharti Airtel and MTNL.

Note: Monthly Broadband Report for March, 2012 had been received from 97 ISPs only till the compilation of this report. For the remaining ISPs, previous month's data has been taken.

VLR Subscribers in the Wireless Segment

Home Location Register (HLR) is a central database that contains details of each mobile phone subscriber that is authorized to use the GSM core network. The HLRs store details of every SIM card issued by the mobile phone operator. Each SIM has a unique identifier called an International Mobile Subscriber Identity (IMSI), which is the primary key to each HLR record. The HLR data is stored for as long as a subscriber remains with the mobile phone operator. HLR also manages the mobility of subscribers by means of updating their position in administrative areas. It sends the subscriber data to a Visitor Location Register (VLR).

Subscriber numbers reported by the service providers is the difference between the numbers of IMSI registered in service provider's Home Location Register(HLR) and sum of other figures as given below:-

Visitor Location Register (VLR) is a temporary database of the subscribers who have roamed into the particular area, which it serves. Each base station in the network is served by exactly one VLR; hence a subscriber cannot be present in more than one VLR at a time.

If subscriber is in active stage i.e. he is able to send/receive calls/SMSs he is available both in HLR and VLR. However, it may be possible that the subscriber is registered in HLR but not in VLR due to the reason that he is either switched-off or moved out of coverage area, not reachable etc. In such circumstances he will be available in HLR but not in VLR. This causes difference between subscriber number reported by the service providers and numbers available in VLR.

The VLR data calculated here is on the basis of active subscribers in VLR on the date of Peak VLR of the particular month for which the data is being collected. This data is to be taken from the switches having the purge time of not more than 72 hours.
