2.1 Cellular Mobile Telephone Service:

The objective assessment of quality of service of the service providers, namely, M/s Aircel, Airtel, Etisalat, Idea, BSNL, RCOM GSM, TTSL GSM, Videocon, Vodafone, Uninor, RCOM CDMA, TATA CDMA was conducted during the period from April, 2011 to June, 2011.
