Sub:- Filling up the posts of 'Senior Research Officer' on deputation on foreign service terms in TRAI headquarter, New Delhi.

Telecom Regulatory Authority of India (TRAI), New Delhi is a statutory body set up under an Act of Parliament viz. TRAI Act, 1997. TRAI has been established to regulate the Telecommunications Services and to protect the interest of service providers and consumers of the telecom sector, to promote and ensure orderly growth of the telecom sector and for matters connected therewith or incidental thereto. The functions relating to regulation of Broadcasting and Cable Services Sectors have also been entrusted to TRAI from 2004.

2. The Organization proposes to prepare a panel for filling up the vacant posts of 'Senior Research Officer' **in its Hqrs in New Delhi** on deputation on foreign service terms initially for a period of two years. Existing vacancies are in the field of **"Technical, Legal, Economic and Administration"**. The details of qualification and experience etc. are as under:-

The officer must possess the working knowledge of computer. Essential:- A Master/Bachelor's Degree in Business Administration/Economics/Commerce/Engineering /Law/ Science/ Humanities from a recognized University/ Institution or, Membership of the Institute of Chartered Accountants of India/ Institute of Cost and Works Accountants of India and possessing requisite experience in the relevant field. Age:- Not exceeding 56 years on the date of closing of applications.
