The Telecom Regulatory Authority of India (TRAI), New Delhi, is a statutory body set up under an Act of Parliament viz. the TRAI Act, 1997. The organization proposes to prepare a panel of Officers having the required experience for appointment as Senior Research Officer in its B&CS Division on deputation basis initially for a period of two years. The details of qualification and experience, etc., are as under:-

1.	Senior Research Officer (B&CS)	Rs 10000-15200 plus allowances such as DA, HRA, CCA etc. as per Govt. Rules.	Officers of the Central/ State Govt. / PSUs (i) holding equivalent post on regular basis or (ii) officers in Junior Time Scale with 4 years of regular service in that grade or 7 years of regular service in the grade of Section Officer or equivalent or 7 years of combined service in the Junior Time Scale/ Section Officer's grade. The officer must possess the working knowledge of computer. Preference will be given to candidates who have experience in the field of Broadcasting.

2. TRAI has been exempted from the rule of immediate absorption upto 23.01.2008 by Department of Pension & Pensioner's Welfare for appointment on deputation.

3. With effect from 6.12.2006, the office of TRAI is likely to shift to 'Mahanagar Door Sanchar Bhavan', Jawahar Lal Nehru Marg, New Delhi. All the Ministries/Departments/PSUs are requested to forward applications in the enclosed proforma alongwith attested copies of ACRs for the last five years and vigilance clearance of eligible candidates whose services could be placed at the disposal of the Authority immediately so as to reach **Senior Research Officer (A&P), Telecom Regulatory Authority of India, 'Mahanagar Door Sanchar Bhavan', Jawaharlal Nehru Marg (old Minto Road), Next to Zakir Husain College, New Delhi – 110 002.**
