**Sub: Filling up of the posts of Senior Research Officer in TRAI (Headquarter),  
New Delhi on deputation on foreign service terms.**

Sir,

Telecom Regulatory Authority of India (TRAI), New Delhi, is a statutory body set up under an Act of Parliament viz. the TRAI Act, 1997. TRAI has been established to regulate the Telecommunications Services and to protect the interest of service providers and consumers of the telecom sector, to promote and ensure orderly growth of the telecom sector and for matters connected therewith or incidental thereto. The functions relating to regulation of Broadcasting and Cable Services Sectors have also been entrusted to TRAI from 2004.

2. The organization proposes to **fill up of the posts of Senior Research Officer in its Headquarter, New Delhi** on deputation on foreign service terms, initially for a period of two years. The details of qualification and experience etc., are as under:-

Pay Level:	Pay Level-11 in the Pay Matrix under 7 <sup>th</sup> CPC  [Pre-revised PB-3, Rs. 15600-39100+ GP Rs. 6600] with allowances such as DA, HRA etc. as per Govt. Rules.
Eligibility criteria:	Officers of the Central Government, Central Public Sector Undertakings and Statutory and Autonomous Bodies:- (i) Holding equivalent post on regular basis <u>OR</u> (ii) Officers in Junior Time Scale with 4 years of regular service in that grade <u>OR</u> 7 years of regular service in the grade of Section Officer <u>OR</u> any other equivalent <u>OR</u> higher grade. The officer must possess the working knowledge of computer.
Qualification:	A Master/ Bachelors Degree in Business Administration/ Economics/ Commerce/ Engineering/ Law/ Science/ Humanities from a recognized University/ institution or, Membership of the Institute of Chartered Accountants of India/ Institute of Cost and Works Accountants of India and possessing requisite experience in the relevant field.



3. The appointment will be made on deputation on foreign service terms and will be governed by the instructions issued by the DoP&Trg. OM No. 6/8/2009-Estt. (Pay II) dated 17<sup>th</sup> June, 2010, as amended from time to time. **The maximum age for appointment on deputation shall in no case exceed 56 years on the date of closing of applications in TRAI.**

4. All the Ministries/Departments, Central Public Sector Undertakings and Statutory and Autonomous Bodies are requested to forward applications in the prescribed proforma (*can be downloaded from TRAI's website [www.trai.gov.in](http://www.trai.gov.in)*) along with attested copies of ACRs/APARs for the last five years and vigilance/disciplinary clearance of eligible candidates whose services could be placed at the disposal of the Authority immediately in the event of their selection. The application should be sent in an envelope superscribing the post applied for to the **Senior Research Officer (A&P), Telecom Regulatory Authority of India, Mahanagar Door Sanchar Bhawan, J.L. Nehru Marg (Old Minto Road), next to Zakir Hussain College, New Delhi-110002 on or before 15<sup>th</sup> March, 2019.**
