Sub:- Filling up of the post of Advisor (Legal) on deputation on foreign service terms.

Sir,

Telecom Regulatory Authority of India (TRAI), New Delhi is a statutory body set up under an Act of Parliament viz. TRAI Act, 1997. TRAI has been established to regulate the Telecommunications Services and to protect the interest of service providers and consumers of the telecom sector, to promote and ensure orderly growth of the telecom sector and for matters connected therewith or incidental thereto. The functions relating to regulation of Broadcasting and Cable Services Sectors have also been entrusted to TRAI from 2004.

2. The organization proposes to fill up the post of Advisor (Legal) on deputation on foreign service terms initially for a period of two years. The details of qualification and experience etc, are as under:-

3. Officers holding the post having HAG scale i.e Rs.67000-annual increment @ 3% - 79000/- on regular basis or (ii) Officers in Senior Administrative Grade with three years of regular service in that grade or (iii) Group A officers having twenty one years of regular service in Group 'A' of which at least three years of regular service in the Senior Administrative Grade may also apply and in case of selection he/she may be considered for appointment as Principal Advisor in the HAG scale i.e Rs.67000-annual increment @ 3% - 79000/-.

4. This post has been exempted from the rule of immediate absorption up to 23.1.2016 by Department of Pension & Pensioners Welfare for appointment on deputation.

5. All the Ministries/Departments, Public Sector Undertakings and Statutory and Autonomous Bodies are requested to forward applications in the enclosed proforma (can also be downloaded from TRAI website www.trai.gov.in) along with attested copies of ACRs for the last five years and vigilance/disciplinary clearance of eligible candidates whose services could be placed at the disposal of the Authority immediately, in the event of their selection.
