Sub: Calling applications for filling up the post of Senior Research Officer (Engineering) on deputation on foreign service terms

Sir,

The Telecom Regulatory Authority of India (TRAI), New Delhi is a statutory body set up under an Act of Parliament viz. the TRAI Act, 1997. The organization proposes to prepare a panel of officers having the required experience for appointment as Senior Research Officer (Engineering) on deputation on foreign service terms initially for a period of two years. The details of qualification and experience etc, are as under:-

Senior Research Officer	Rs.15600 -39100 + grade pay Rs.6600/- plus allowances such as DA, HRA, etc as per Govt. Rules	Officers of the Central Govt., Public Sector Undertakings and Statutory and Autonomous Bodies (i) holding equivalent post on regular basis or (ii) Officers in Junior Time Scale with 4 years of regular service in that grade or 7 years of regular service in the grades of Section Officer or equivalent or 7 years of combined service on regular basis in the Junior Time Scale/Section Officer's grade. The officer must possess the working knowledge of computer. <u>Essential:</u> A Master/Bachelor's Degree in Electronic Engg. and/or Telecommunications Engineering from a recognized University and possessing requisite experience in the telecommunication field. <u>Age:</u> Not exceeding 56 years on the date of closing of applications

2. The Appointing Authority may, from time to time, by appropriate order, appoint on permanent absorption basis any person already appointed on deputation in the Authority in accordance with provisions contained in TRAI Appointment Regulations.

3. TRAI has taken up the matter with the Government for exemption from the applicability of the rule of immediate absorption for all posts in TRAI.

Nehru Marg, (Old Minto Road), next to Zakir Husain College, New Delhi-110 002 on or before **30th September 2009**.
