1. Recommendations

1.1 TRAI has sent its Recommendations regarding the platform services on 2nd February 2021 to the Ministry of Information and Broadcasting (MIB) on its back references:

Platform services are the programming services which are specific to the platform and are not obtained from satellite-based broadcasters. These programming services are either produced by the Distribution Platform Operators (DPO) viz. MSO, DTH itself or are sourced from certain local content producers.

TRAI gave its recommendations on the subject in 2014 and also in 2019 specifically for DTH. TRAI received two letters dated 23rd October 2020 from MIB referring back some of the issues in these recommendations for reconsideration.

In the first back reference, MIB has referred-back some of TRAI's recommendations dated 19th November 2014 on "Regulatory Framework for Platform Services" for reconsideration. In the second back reference, MIB proposed some of the TRAI recommendations on "Platform Services Offered by DTH Operators" dated 13th November 2019 to be adopted by MSOs also.

In this context, as some of the issues had not been specifically put into the consultation earlier, TRAI issued a consultation paper in the form of draft response of TRAI on 7th December 2020.

After considering the observations of MIB, written comments from stakeholders and its own analysis, the Authority has finalised its recommendations and sent it to the Ministry of Information and Broadcasting (MIB) on both the back references. The Authority gave its reconsidered recommendation on MIB views on the following issues:

- Anybody registered as a distributor, either with MIB or with a post office shall be eligible to carry platform service channel: TRAI indicated that it has no objection provided MIB ensures that the platform service provider discloses ownership status and complies with the program and advertising codes.
- MSO may be permitted to a maximum 5% and LCO to a maximum of 1% of total permitted satellite channels being carried out by them as the permitted platform service channels: TRAI recommended a maximum 15 Platform service channels for Distributors.
- MIB may withdraw from distribution of platform service channel if it is inimical to Indian National Security: TRAI agreed and suggested to

MIB to put a condition that the Distributor must notify if there is any change in the ownership/control.

The Authority also agreed with the view of MIB to adopt the recommendations regarding the Platform Service for DTH, to other distributors such as MSOs, IPTV, and HITS on the following aspects:

- o Definition of platform service.
- o Conditions for platform service which include:
 - Not sharing the platform service channel with other distributors.
 - o No registered TV channel or time shifted channel shall be transmitted as a platform channel.
 - o Undertaking on these aspects.
 - o TRAI can stop such channels if it is non-compliant. MIB can cancel the registration of distributor
- Distributors shall provide option to activate/deactivate Platform service subject to orders/regulations/directions of TRAI.
- Platform service channels should be categorised under genre "Platform Service", MRP shall be displayed, and the caption should be displayed to distinguish from linear channels.

2. Directions

2.1 TRAI issued a direction on 15th February 2021 regarding the submission of Performance Monitoring Report to the Authority under the Telecom Commercial Communication Customer Preference Regulations, 2018.

The Authority regulates unsolicited commercial calls/messages through the Telecom Commercial Communication Customer Preference Regulations, 2018.

There exists a provision in regulation 26 of these Regulations that every access provider shall submit its compliance reports in the manner specified by the Authority from time to time. Under this provision TRAI specified reporting formats to service providers vide direction dated 6th August 2019.

Now, on request from service providers and to monitor the overall performance of the measures taken by the access providers, these formats have been revised through this direction.

2.2 TRAI issued Direction to various MSOs:

TRAI issued directions on 9th February 2021 to MSOs viz. M/s UCN Cable Network Pvt. Ltd., M/s Kerala Communicators Cable Ltd., M/s KAL Cables Pvt Ltd., M/s GTPL Hathway Ltd., and M/s Fastway Transmissions Pvt. Ltd., to ensure compliance to the New regulatory framework of Broadcasting and cable services. These directions were issued after it was observed that the said MSOs have not complied with certain provisions of the new regulatory framework.


