

Sub: Recommendations on consultation paper on "Unsolicited Commercial Communication (UCC)".

The Bharatiya Janata Party (BJP) uses telecom services for the following purposes:

1. Membership

The Party, in Nov 2014, launched a nationwide 'missed call' campaign to enrol new members. It today has over 11.4 crore members. We have used a toll-free number 18002662020 for the membership drive.

2. For political campaigns and information dissemination

This involves communication with members of the party who have chosen to opt-in to the service. None of this is a commercial activity.

Based on the above, we have the following recommendations:

- (I) BJP is a political party and should be exempted from transactional/promotional SMS charge of 5 paisa/SMS.
- (II) Sender id length should vary between 6 to 8 characters and numeric characters should be allowed too.

- (a) Official sender id needs to be white listed through a one-time approval process authorised by designated office bearer of the party.
- (b) Any new sender id which is approved by the authorised office bearer of BJP should be approved by competent authority
- (c) All similar/duplicate id must be barred from sending SMS and discontinued.
- (IV) A political organization like the BJP should not be required to validate mandatory opt-in every six months. If a member wants to cancel his/her membership then we will provide a specific web link/number where they can text to opt out.
- (V) In cases where the existing number has been allocated to another person and he complains to TRAI against unsolicited SMS/calls, the organization should be given 10 working days to remove the number from the membership database. Such requests can be sent via TRAI or through the web link/number we put on our website.

I hope you will take the above suggestion in good faith and provide us with an enabling working environment.
